

Warehouse Management

ASSIST4 Warehouse Management has the goods to optimize your order management.

ASSIST4 Warehouse Management has all the features you need to manage warehouses and distribution centers: goods receipt control, site and yard management, inventory monitoring and slotting optimization. All internal goods movements are transparent, and error resistance is built into the initiation and execution of the picking process. Integration with **ASSIST4** Transport and the other modules yields even greater performance and quality throughout the supply chain execution.

DC TopoLogy: ASSIST4 maps any type of warehouse or distribution center: storerooms, transfer storage facilities, distribution centers, modular shelf systems, revolving shelf systems, pallet shelves, bulk storage facilities, free warehouses, high-bay storage areas, small parts warehouses and many more. Each bin location is memorized and can be identified down to the shelf or tray level, so that the system contains a 1:1 mapping of your actual warehouse. It's even possible to map hierarchical warehouse structures—for example, if a warehouse includes one or more subwarehouses but you still need higherlevel or cumulative inventory informa-

Intake-Grity: ASSIST4 Warehouse Management supports the entire goods receipt process: from the receipt of pallets and warehouse utilities to material and quantity checks, returns handling and optimal storage bin placement. ASSIST4 even handles steps such as repackaging,

palletization, labeling and QA testing to ensure an error-free basis for all warehouse data.

Warehouse Cockpit: All inventory is transparent. All goods movements are monitored. ASSIST Warehouse Manage ment monitors all warehouse orders down to the level of the individual transport order. Bin and resource capacity utilization is visualized here in real time. Even communication with the material flow computer that controls automated storage and conveyance technology is monitored. Effective search tools like the Stock Cockpit also give you continuous real-time visibility of stock levels in the various warehouse locations all the way down to the material level.

Warehouse Mobil-IT-izer: ASSIST4 delivers mobility so you can harness the full efficiency potential in your warehouse processes—whether you're using a wireless handheld device to check incoming goods or executing paperless picking. You even have a mobile connection to forklift control systems. Auto ID technologies such as bar codes and RFID enable continuous control of the material flow.

IntelliCount: Everyone needs to take physical inventory, but it doesn't have to be a headache. ASSIST4 Warehouse Management handles the counting but lets you determine the method: periodic inventory, continuous inventory—even sample-based inventory, where permitted under law. You can choose between physical inventory based on the material or the bin.

Auto Replenishment: ASSIST4 gives you great flexibility in controlling replenishment—which is particularly helpful where fast-moving items are stored and picked. This completely auto-

mated feature ensures that your stock never falls below a defined minimum level. Fast-moving merchandise is flagged early on and automatically replenished before it can run out. The result is more efficient warehouse processes, with significantly streamlined picking and replenishment control as a manageable, ongoing standard process. ASSIST4 Warehouse Management even lets you implement VMI solutions.


Work-Force-Balancer: How you deploy your workforce in the warehouse is critical for the performance of your warehouse processes. ASSIST4 has various tools to help you adapt your resource planning to actual conditions so you can respond quickly even to unanticipated fluctuations. This yields constant transparency in the capacity utilization of the picking and packing workforce. Spikes in demand are identified early on through resource planning, making it possible to respond proactively. Above all, this provides the flexibility needed for prioritized control of order management even in peak times.

Perfect Picking: It doesn't matter whether you prefer one-phase picking based on a resource-guided pull principle, two-phase picking in batch runs or picking optimized by zone, time or quantity. You can even employ a combi-

nation of the various strategies. Document-free picking is supported by applications for mobile recording devices in the same way forklift control systems are. ASSIST4 Transportation seamlessly integrates the subsequent process transition to packaging and loading.

HU Handling: Dividers such as pallets, crates or workpiece holders are of tremendous importance in facilitating the storage and handling of warehouse goods. ASSIST4 Warehouse Management plays just as important a role by allowing unlimited management of merchandise and dividers within so-called handling units. Handling units and ASSIST4 HU Handling accelerate your warehouse processes, whether you use dividers to combine warehouse merchandise or to protect your warehouse goods by manipulating conveyance methods or affixing information.

Cross Dock: ASSIST4 Warehouse Management supports all modes of direct cross-docking (especially items with a fast turnover) and, together with ASSIST4 Transport Management, offers the necessary execution tools to efficiently cross-dock merchandise for immediate onward shipping. Since ASSIST4 supports both processes—picking and consolidations—you have the option of either one-phase or two-phase cross-docking.





Transport Management

If warehouse management is the heart of supply chain execution, transportation management is the bloodstream.

ASSIST4 Transport Management lets your goods and information flow: standardized and automated along the supply chain you define. Jobs are consolidated to save costs and the most affordable carrier is automatically selected for each job—in both procurement and distribution processes. The ASSIST4 Docu-Scout applies defined rules to suggest all the documents and electronic messages required for complete 4C compliance.

IntegRates: ASSIST4 Transport Management lets you enter and process jobs. Jobs are often transferred from other systems such as SAP®, Microsoft Dynamics®, Oracle, Infor, etc. Business objects such as orders, deliveries or invoices are the basis.

ConsoliDates: ASSIST4 monitors and controls this transfer, consolidating the data according to predefined rules. For example, multiple orders for the same customer are consolidated onto one delivery note. This process paves the way to enormous savings, since it drastically cuts documentation, handling and transport costs.

provides you with information on pricing, schedules and routing for the service types of over 50 carriers, forwarders and courier/express/parcel services worldwide. Your individual service level agreements (SLAs) are also loaded for easy comparison. ASSIST4 uses all this information to automatically select the fastest or most cost-effective carrier for your deliveries.

Carrier Connections (Freight Forwarder

agreed rules and specifications. And this is precisely one of the major benefits of ASSIST4. Your business processes are standardized, so you can reach what is known as "4C compliance": corporate, customer, carrier and customs. ASSIST4 plays by the rules and secures your processes according to the specifications of your company, customers, supply chain partners and, last but not least, the rules set by the customs office. A perfect example: the Docu-Scout.

Docu-Scout: The ASSIST4 Docu-Scout applies all 4C compliance specifications in automatically determining all the forms, business papers and EDI messages relevant to each process-for nearly every country and carrier. A consignment can't leave your plant until the necessary messages and labels have been created. A customs consignment requires a customs declaration. And if a forwarder requires a proforma invoice, ASSIST4 will let you know. This enables secure, automated and standardized processes, enhances the quality of your workflow, reduces delays and reinforces the relationship to your customers, suppliers and partners.

One-Stop Shop Packing: ASSIST4 combines multiple supply chain execution steps in one place: the packing station, a highly integrated workstation designed for highly efficient checking, packing and weighing of picked goods. Scanners and integrated scales minimize the data that needs to be input through the mouse and keyboard—thereby reducing the error rate. Much of the work handled here would otherwise have to be done in the despatch office, such as printing delivery notes, packing lists and the corresponding labels.

IntelliTrackIT: ASSIST4 doesn't just help you with your supply chain execution. It also provides comprehensive support in

controlling and monitoring your supply chain. Every business process handled through ASSIST4 can be tracked in ASSIST4 Monitoring & Alerting. This gives you complete transparency or visibility. ASSIST4 Monitoring & Alerting also proactively monitors all scheduled process runtimes (see page 14). Conversely, every object that ASSIST4 processes in your supply chain execution contains an overview of all associated events and messages received up to that time, so you have complete visibility even at the execution level.



Freight Management

Much more than just transparent transports: Minimize your freight costs. Maximize your cash flow.

ASSIST4 Freight gives you efficient control over your transport costs, letting you know in advance exactly what your costs will be and providing you with self-billing and e-billing options to automate your invoice processes while giving you complete control over costs throughout the entire process. It doesn't matter whether you calculate your freight costs in advance to support sales or during goods issue/receipt.

Quotes & Contracts Qualifier: A complete set of quotes is the basis of all freight calculation. ASSIST4 works with your quotes, analyzing the various methods of calculation, cost components (weight, distance in road kilometers or tariffs, zone- and freight-dependent costs) and SLAs. Quotes that would otherwise be inscrutable—road, air or sea, even in foreign currencies—can then be compared with the click of a mouse.

Freight Cost Calculator: ASSIST4 uses this basis to calculate your freight costs for each delivery or transport so that information on freight costs are uniform throughout the company and always up to date. This makes it possible to quickly and securely automate the reallocation of freight costs to customers, suppliers or internal cost centers.

AlternaTips: Simulations and advance inquiries also utilize the base quotes, lending flexibility to the decision-making process. Which mode of transport would be most affordable? Which carriers are possibilities for a given route? Which of those is the most cost-effective? The most reliable? The Freight Calculator business service has answers to all these questions.

Auto Audit: Double-checking incoming freight invoices is time-consuming, which is why many companies unfortunately never get around to it. ASSIST4 Freight gets you back on track. ASSIST4 is familiar with all the quotes and has often calculated the freight costs in advance, so incoming invoices are automatically double-checked. If the invoice matches the precalculation, payment instructions are automatically forwarded to Financial Accounting. But if the ASSISTant finds a discrepancy, a proactive alert is generated.

Self-Billing: Switching to a self-billing procedure is faster still. Instead of waiting for the invoices from your transport service providers, you can send them "credit notes" for the freight costs calculated by ASSIST4.

E-Billing Enabler: All these processes for calculating and paying freight costs can be carried out electronically with even greater automation. ASSIST4 can initiate payment transactions in your financial system, receive and process electronic invoices such as those in EDI format from your business partners and transmit the credit notes back along the same path.

ASSIST4 Compliance offers effective protections that let you identify listed individuals, companies, groups and organizations. Business relations that would violate an embargo are thus identified in time and prevented. Depending on the demands and your current IT infrastructure, ASSIST4 Compliance can either be run as a standalone application or fully integrated into your existing application solutions.

Comply: ASSIST4 Compliance thus ensures compliance with the array of legal regulations in the battle against terrorism and money laundering. The objective is to protect your enterprise and staff from financial and criminal liabilities. Background compliance checks identify undesirable or illegal transac-

tions, stopping or interrupting them before they can be carried out.

SophistiSearch: Sophisticated test logic even identifies similarities such as spelling variants or word transpositions. You have the option of running individual checks in real time for each transaction or setting regular batch process checks for specific data.

Lists and test schemes: Up-to-date sanctions lists are the foundation of any secure compliance solution. Individual lists are updated with new or modified entries at irregular intervals, often several times a month. Staying on top of this task requires an automated update service - an integral component of ASSIST4 Compliance. ASSIST4 Compliance is designed to manage a broad spectrum of different sanctions lists. The lists freely available on the internet can be supplemented by those offered by various data providers, so that in addition to EU and US legal guidelines, it is possible to integrate the regulations of other jurisdictions – Japan, Canada or Switzerland, for example.

Automatic update service: The scope of the update service is tailored to the customer's individual needs. Data is always consolidated daily by AEB and sent out whenever there have been changes. The update is a fully automated background process without the need for any user interaction. All checklist "deltas" and changes are fully logged in ASSIST4 Compliance. In addition, the user group receives e-mail notification of any modified list entries.

Custom lists: In addition to the official sanctions lists, ASSIST4 Compliance lets you administer any number of customized lists. There are many reasons why business relationships are broken off or certain individuals or companies

are subjected to a delivery block. Such cases can be handled in "bad guy" lists and integrated into the compliance check process. This ensures full compliance with maximum flexibility. The various search strategies yield particularly reliable screening. In some instances, however, certain addresses are identified as "suspicious" even though they are known to be free of any links to terrorism. ASSIST4 Compliance lets you store such addresses in your company's own "good guy" lists. Such addresses are exempted from checks if there is an exact match.

Logging and monitoring: The complete logging of all activities is a core function of ASSIST4 Compliance. Every single query, any match and all changes to list entries are exhaustively recorded. An internal information management system lets you notify the appropriate parties by e-mail. The distribution list used for notifications can vary based upon the compliance check results or the type of log. This guarantees thorough verification and complete transparency.

Client-enabled: A single central Compliance Engine can be shared both by various business process applications and various clients. Profiles allow you to maintain separate lists, compliance check profiles and notification lists and to differentiate various authorization groups and users. ASSIST4 Compliance also distinguishes queries via online interfaces, logs them and applies parameters and settings based on the querying system.


